Spiritual Advisor Message

The exciting month of November has children waiting for the approach of Christmas, adults making similar plans, Thanksgiving weekend, football games and the arrival of icy weather. The month of November begins with All Saints Day, followed by All Souls Day. All Souls Day, along with every day in November, is a traditional time for visiting graves of deceased family and friends, remembering them in prayer and gifting them with the benefit of indulgences we've gained. So often we forget that there are souls awaiting the completion of their purification by our prayers and actions.

November's calendar daily honors saint after saint, including one of my favorite, Father Miguel Pro, now Blessed Miguel Pro, on November 23rd. He lived for about a month in San Antonio and was one of hundreds of martyr-priests executed by the Mexican government in 1927 for the crime of celebrating Holy Mass.

On the 21st of November, is the Presentation of the Blessed Virgin Mary. There is something special about honoring Our Blessed Mother. Then the very next day, Sunday the 22nd, the last Sunday in Ordinary Time, is the Solemnity of Our Lord Jesus Christ, King of the Universe. And finally, it's Turkey Day--Thanksgiving--the secular holiday of family gatherings, football on TV and of course turkey along with customary family gluttony.

All too often, we celebrate this secular day, and it is not even a holy day! We just forget about God and his goodness toward us. Most of us do not attend Mass that day, although it would be good to do so. Instead, moms are cooking in the kitchen, and dads making barbecue in the back yard next to the beer cooler. Some of the men are even missing--they're at the deer camp having their own fun.

I will suggest you start to do this as an annual practice—instead of a simple prayer before meals, do a little longer prayer really thanking God in your own words. God really does love us and knows all about us; we are always on his mind, and He waits to hear from us. Maybe you could even light a candle in the center of the table and say one or two verses of Scripture. Who is going to do it? Mom or Dad? Maybe every year someone else will lead the prayer? You know doing this will touch God's Heart! Your family will look forward to this special moment every year at Thanksgiving. It will likely become an important part of your traditional Turkey Day!

Finally, November 29, the last Sunday of the Church Year, is also the First Sunday of Advent. With evening prayer, the new year of the Church begins--the Year of Grace! Have a great month!

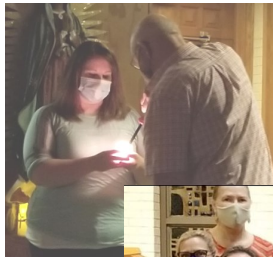

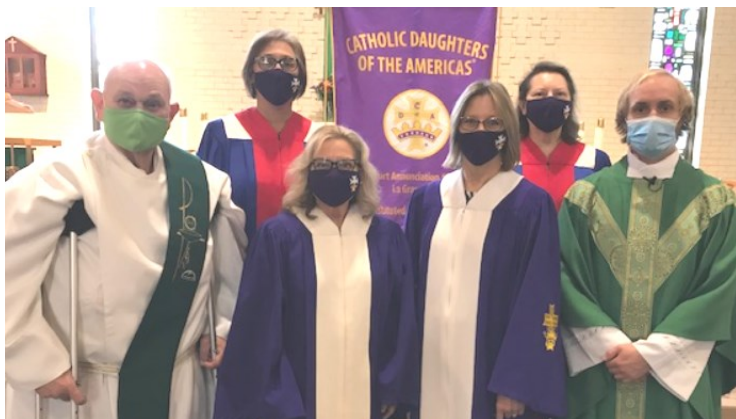


National CDA Sunday

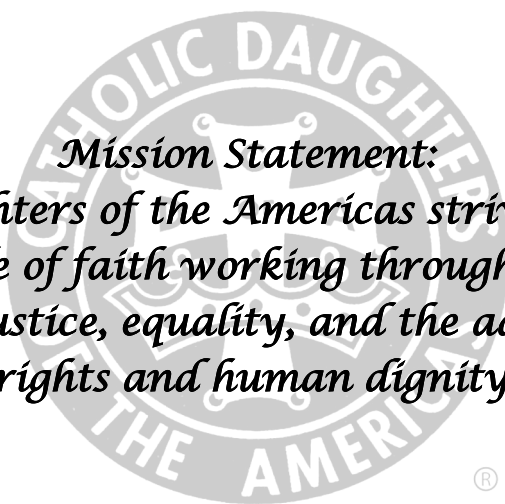
